GENERAL INFORMATION

Club 4 Kids is set within its own, securely fenced area in the grounds of Hampton School with its own entrance.

We are a private, independent group, although maintain close links with local schools.

We promote our equal opportunities policy and therefore expect children to respect this and not show any sexist or racist behaviour.

We are, under the CHILDRENS ACT 1989, required to report any unusual circumstances in which a child's welfare may be in danger.

We welcome visits, but due to security and safety of the children, our gates will be locked at set times. So please telephone before your arrival. We also welcome visits from parents, carers and people in the community who have an interesting hobby they wish to share and feel the children would benefit from seeing.

We are permitted to administer medication provided it is prescribed by a doctor or Pharmacist and clearly named with a pharmacy label and you give signed authorization on every day required.

We are covered by the General Data Protection Regulations (GDPR) 25th May 2018 - please see Parent Information Board for relevant information.

We do not issue invoices or statements automatically but will gladly issue them on a written request to do so. Please indicate on your request whether you wish to receive them by email or hand. A £10 Admin Fee will be payable for all back dated invoices/receipts requested including HMRC and council "Proof of childcare" forms.

STAFFING RATIOS

Our club is staffed to a ratio as defined in the OFSTED Statutory Requirements April 2017

1:4 children aged 2 to 3 years

1:8 children aged 3 to 7 years

During outings, staff ratios may be exceeded.

POLICIES

We have a vast range of policies on display in our main reception area, should you wish to have a copy please see a member of staff.

We expect parents/carers to adhere to these policies for the development and well being of all children and staff within the setting.

Please find enclosed a registration form for the Holiday Playscheme.

A full list of planned activities are shown on the booking form which you should receive approximately 4 weeks before Playscheme starts.

The Two to Fours Playscheme operates various sessions from 8-9, 9-12, 12-3, 9-3, 3-5 and 5-5.30

Full fees are payable on booking and charges are:

Booked place: 8-9 = £3.20, 9-12 or 12-3 = £9.60,
9-3 = £19.20, 3-5 = £9, 5-5.30 = £2.50

Less than 14 days notice of cancellation = No refund

Children should be collected by an authorised adult no later than booked finish time. A charge will be made for late collections.

Places are available on a first come first served basis. A reserve list will operate if full and the admissions policy will apply.
